## Cookies

In order to offer you the best service and facilitate its use, the Spanish National Securities Market Commission's website uses cookies (files stored on the device of those who access certain websites with the aim of storing and recovering information on the navigation carried out from that device) for technical purposes and to the extent necessary for the correct functioning and visualisation of the website by the user.

The cookies used on the CNMV's website, are all own cookies, have a temporary, limited duration and are used to customise browsing experience, as well as to identify and remember users registered with the subscription section for "Public communications from entities" (with no personal data) and who access the Virtual Office.

- Language cookies: these cookies are used to remember the language used by users in their last visit to the CNMV's Portal or the Virtual Office, such that, in subsequent visits, the pages are displayed in such language without requiring user interaction.
- Log cookies: in order to have users identified during the creation and amendment process of the subscription section for "Public communications from entities" and when they access the CNMV website, log cookies are generated each time users log on. In the case of subscriptions for "Public communications from entities" the email data entered is stored and when users access the CNMV Virtual Office, the date, time and identifier of the session are stored. These functions can be deleted by using the "Log off" option, in which case, the next time that users log on, they must be identified via the user "Login".
- ID Cookies: in the "IPP" procedure ("Interim Financial Reports" procedure for issuers of securities admitted to trading) on the CNMV Virtual Office, the Tax Id. Code (CIF), type and name of the firm, contact email address, User Id. and Tax Id. Number of the person associated with the User Id. to login are stored, as they are necessary for such procedure.
- Personalization Cookies: these allow users to access the service with certain preset features and preferences on their device in terms of, for example, the type of browser used to access the service, the regional settings for access to the service, the accessibility settings configured by the user, etc.

Furthermore, in order to access the CNMV Virtual Office, the use of cookies on the browser must be enabled. In the case of the "Interim Financial Reports" procedure for issuers of securities admitted to trading, users have to accept the terms and conditions of use for cookies.

## CNMV APP

CNMV has made available to the public its mobile app, which can be acquired free of charge through the Apple Store and Google Play.

This application collects the following data:

- Data used for technical purposes and which is absolutely necessary to allow the user to operate and view the application properly, such as their IP address, certain features of their device, their device's operating system and the language that they use.
- Data whose purpose is to personalise the application according to the user's interests, facilitating its use without the need for their interaction. This is the case of "push" notifications whose configuration is determined by the user, who can enable and disable them when they wish.
- Data used by the application to compile and analyse statistics on usage and segmentation of user interests, such as log-in times, the country and time zone where the user logs in to the app, as well as other applications that they have installed on their device.
